# \*\*\*\*\*\*\*Expectations from the JU, including the Scope definition. Interaction with CASTIEL\*\*\*\*\*\*\*

- JU: CASTIEL as a coordinated support action for EuroCC-project
  - Will enrich the HPC landscape in Europe
  - - High expectations for the projects
- Interaction with CASTIEL: EuroCC will be on the national level, CASTIEL will be a Gate to Europe, the projects will interact.
  - - From the management perspective, it's one big project
  - · Most important point: The NCCs should benefit
  - · Goal: NCCs keep their national identity, but embedded in a European framework
  - Next weeks: HLRS will collect key persons, to form working groups guided by CASTIEL
  - .
- -CAB: There is a Competence Centre Advisory (CAB) of CASTIEL with five elected representatives of the NCCs
  - - Further instructions for the voting will follow soon

- Scope: set up of a framework to run and train NCCs, identification and coordination of services and competences,  $\dots$ 
  - - not in the scope: R&D, Administrative Tasks, Existing training etc.

- - Do countries in CASTIEL vote for the 5 representatives? voting yes, being voted no
- I saw that Existing education/training is non-eligible as per the scope. But the
  question is if the existing educational/trainings can be considered as National
  Competence? (including in those offered as services in private sector). Yes
- Do we do a joint action of linking to other related initiatives like FF4/EOSC et al. -Yes
- Is any activity on country level 'related to HPC' eligible EuroCC activity or there should be a strict relation with EuroHPC? Do NCC promote HPC or EuroHPC? - Both, it's not strictly connected with EuroHPC, funding comes from the EU and the nations.

## \*\*\*\*\*\*\*\*\*\*Competence Maps - the approach\*\*\*\*\*\*\*


- Not only the competences matter, also the needs and gaps
  - The gap sizes naturally differ, every country has different stakeholders, users, priorities and competences already available etc.
  - The needs also differ, and countries will have different development paces and scopes
  - - EuroCC's role: best possible support and guide you so your country can most benefit from it, so we have a strong European NCC network.
- Benefits are enhanced services for academia, industry demands and public administration.
- Task x.5: Mapping of HPC/Big Data/Ai Technical competences: Services, Infrastructure, Users & stakeholders
- CASTIEL will also help with the competence mapping, will give access to best practices, offer workshops etc. and organize networking possibilities

- Will you supply templates for the competence mapping in order to facilitate easier and more efficient lockup? - We have sketched something which will be handed over to the WP in CASTIEL. We want the working group to discuss this at the end of the month to ensure that you know what is needed in terms of description
- Does this include a special training platform that will be offered? We will see if we reuse/integrate existing training registries. Then we will identify the delta between what is there and what is needed

# \*\*\*\*\*\*\*Administrative issues, tools, mechanisms\*\*\*\*\*\*\*

- Consortium Agreement: Contains regulations etc. (Some signatures are missing)
- Amendment for Budget re-allocation needed only in some cases
- Eligible (e.g. personal costs) and ineligible costs (e.g. debt) are defined in the GA
  - personal costs: salaries plus social security charges and other statutory costs
- For countries with third parties: Third parties are only eligible under certain conditions(see slide on BSCW)
- There is reporting needed, e.g. financial (each NCC), internal (each NCC)
- Financing:
  - - Grant amount covered by EU is shortly below 50% (due to in-kind), 50% is reimbursed by the home country.
  - - Pre-financing: rates will be sent if certain requirements are met (see slides)
